Dear Krieg,

I have had a letter from Mr. Finch, in which he writes
as follows:-

"Have noted your Cable #368 requesting us to arrange accommodations for Miss Philinda Jones, on which I already had a letter from her direct, written at the suggestion of Mr. Perry Jester, and I am sorry that we had to cable you as we did, that we could not arrange her passage.

"The War Shipping Administration has full charge of all passage requests on the American vessels and, for reasons best known to themselves, will hardly ever approve passage for a lady on one of the vessels."

"As for #633, it just could not be arranged to put a lady aboard this vessel unless she was traveling on official business, which no doubt Mrs. Price, who is travelling with her husband, can explain to you more fully when she arrives back in Lagos."

"In any case, please present our personal regrets to Vice-Consul Krieg and assure him that if there was any way we could help him it would be our pleasure to do so."

The above is for your information.

Please be sure and let us hear from you in case we can do anything further with reference to helping Miss Jones.
